REGULATIONS GOVERNING FINANCIAL OBLIGATIONS

**Prospective members agree that this application is an obligation
of membership to South Side Country Club for a period of 2
years.**

For purposes of this promotional application, year 1 includes the time from the application date through April 30th, 2027. Year 2 includes the time from May 1st, 2027 through April 30th, 2028.

Members applying as Young Professionals will receive a 50% discount on membership rates in years 1 and 2 of this promotion. To qualify as a Young Professional, a member must be under 40 years of age. Any member that reaches 40 years of age during this promotion will convert to Family or Single member status (depending on marital status) in the month following their 40th birthday. The 50% discount will continue to apply to both years of membership.

Members not applying as Young Professionals will receive a 50% discount on membership rates in year 1 of this promotion and a 25% discount in membership rates in year 2 of this promotion.

All prospective members are subject to food and beverage minimums as set forth by the SSCC Board of Directors. Membership rates and F&B minimums are subject to change as prescribed in the bylaws of South Side Country Club.

The bylaws of the Club provide that application for membership shall be accompanied by the entrance fee if applicable and the amount of membership dues for the current dues period; and the application shall be emailed to the Board of Directors of the Club for review.

All current charges must be paid in full and received by the office by the 20th of each month to avoid an automatic late fee of \$50 added to the subsequent billing statement.

“Pursuant to Section 21 of the bylaws and policies adopted in accordance therewith, any member who is delinquent in payment of dues, capital contributions, assessments, and purchases on credit by more than 30 days shall lose all privileges and use of the club. The undersigned agrees to pay all costs of collection, including reasonable attorneys’ fees, in the event club is required to pursue third-party collection or legal action to recover the amount of the delinquency.

The undersigned agrees that this application constitutes a 2-year obligation of membership at South Side Country Club subject to all bylaws, rules, and policies.
